

## 2018 T'S & C'S

### **Length of enrolment and fees**

1. Once enrolled in a class at Awesome Dancer for commencement in 2018, we'll keep you enrolled until you tell us you need to pause or withdraw.
2. If you need to cancel your enrolment, you must submit written notice on or before the 28th of the month prior to your next scheduled debit to avoid paying for the following period (month or quarter). If notice is received after the 28th of the month, the tuition for the following period will still be charged. The last date of cancellation for 2018 is the 28th of September.
3. Awesome Dancer offers a hassle-free automated payment system. Tuition is automatically charged on the 1st business day of the month on the following schedule.  
Monthly membership - 11 months of the year (February -December)  
Quarterly membership - 4 equal payments (Feb, Apr, Jul, Oct)  
and a receipt is immediately emailed to you. Your initial payment will be discounted to reflect the date from which you enrolled.
4. I have viewed the 2018 prices available on the parent resources page of the website and am aware of the cost of the class in which I am enrolling and I authorise Awesome Dancer to use the account details I have entered for all my account billing. I take full responsibility for payment of all charges and understand that a \$5.50 fee will be charged if a payment is declined.
5. Awesome Dancers fees are all inclusive, there are no additional enrolment fees, rehearsal fees or costumes fees.
6. Awesome Dancer does not offer refunds on their fees for any reason.

### **Permissions and limits on liability**

7. I give Awesome Dancer and their staff have permissions to administer first aid to the student and to arrange emergency medical assistance for the student.
8. I will bare all costs of any emergency medical assistance that Awesome Dancer and their staff organise for the student.

Awesome Dancer will not be liable for any illness, injury or adverse change in medical condition of the student which arises directly or indirectly from any activity the student engages in at Awesome Dancer, or from Student's participation in any competitions, exhibitions or excursions whether organised by Awesome Dancer or not.

11. Awesome Dancer will not be liable for any illness, injury or adverse change in medical condition of the student's or student's parents/guardians or students visitors which arises directly or indirectly from the student/them coming onto or in vicinity of any premises on which dance classes, competitions, or exhibitions are held by Awesome Dancer.

13. I have read and agree to the 'Statement of commitment' available for perusal on the parent resources page of the website.
